

APRN Certification Extension/Waiver Policies — COVID-19 Update

As of April 28, 2020 – 8:45 AM (CST)

Testing Update:

Pearson VUE is reopening all testing sites on May 1, 2020 where governmental entities within the state allow.

Prometric has determined it is necessary to further extend the closure of test centers in the U.S. and Canada through May 31. This applies to all testing programs, **with the exception of essential services programs**, which are still scheduled to resume in a limited capacity on May 1.

PSI will begin opening owned and operated test sites on May 1, 2020. Sites will be opened where governmental entities within a state, city or county allows. The list of open testing locations is being updated regularly and serves as the best reference for candidates and stakeholders.

All eligible clinicians are provided a 120-day testing window.</p>

This has not changed due to the pandemic.</p>	<p>New testing windows begin May 1, 2020, extended through July 30, 2020 for anyone who registered but had not tested.</p> <p>Candidates must register for the NCC exam and provide the required documents to be deemed eligible. If eligible NCC will inform the appropriate state board. NCC will send eligibility letters to BONs in states with emergency certification waivers.</p>

This avoids the 90-day window limit to schedule an exam.</p>
